CCPS AGM 2025 Minutes

Treasurer's Report Margot

Total in bank accounts December 31, 2024, \$5,336.64. Partial financial statement to October 31, 2025, total in accounts \$8,098.46.

Accepted by Jocelyn, seconded by Alexis.

Membership and income was down in 2024 and didn't cover CLRC fees but both improved in 2025 and covered CLRC fees. The 2025 silent auction was a valuable source of income.

Having the accounts amalgamated adds ease and lowers banking fees. Margot has asked CIBC if we could accept e-transfer deposits but was told this was not possible because we have 'two to sign' on our bank transactions. Margot can access the account online but as "view only".

Heather Sherratt must be removed as a signer. Irene will be added on with Margot and Bridget.

Regional Reports - attached

Prairie report presented by Alexis. Pacific report presented by Irene.

Central – no report.

Inspections Susan has tried to contact the ACPS re aligning our inspection criteria but will need to inquire again when the ACPS has completed their inspection reforms.

Margot states we have the finances to hold inspections in 2026 or 2027. Bridget reminded us that the Prairie region has \$6,000 to finance an inspection. Six or eight ponies would be required. Margot and Susan could be asked to inspect with Tracy Dopko in the west and Sarah Thrasher in the east.

Registration and CLRC

Jocelyn reported that in 2024, 12 halfbreds, and 9 purebreds were registered while 11 halfbreds and 14 purebreds were transferred.

Bridget confirms that policy is in place for the CLRC to assign a pony with a HWSD/HWSD and a N/N parent, automatic N/HWSD status.

Jocelyn noted that the new logo is not on the registration papers so an inspection seal must be inquired about. The fee schedule needs to be updated to be at par with other registries as costs have risen. A meeting will be called in the new year to set new fees for 2027 and to discuss the inspection policy.

There was a discussion regarding the policy of registration of halfbred colts.

Awards

Information regarding the awards program is not immediately obvious on the website so needs to be promoted. Siobhan will take care of the program. Reminders to members to send in their applications can be made a few times a year on Facebook, in the newsletter and on a mass email.

Bridget reported that all the older mares that have met the criteria for the Foundation Broodmare Award have received it. No award will be given out for 2025. Members must be asked to submit the names of their mares who meet the criteria as we hope to award a mare in 2026. An email reminder will be sent out.

Jocelyn made the excellent suggestion that Feature Ponies will be posted on the FB page on a regular basis. Any

member can feature their pony with photos and a brief description of why the pony is special, whether it be for achieving awards, being a family favorite, a great trail ride, good company or any reason. The feature can NOT be made for the purpose of sale. These features can be used in a newsletter as well. Members will be asked to contribute in the informational email to be sent by Elsie after this AGM.
